7. Short Notice Events: If your event is less than 7 days away, we require a 50% deposit of the agreed event contracted amount, this payment will be made by credit card. Credit Card Payments are only accepted through PayPal.com and a 5% fee is added to the total.

8. CANCELLATION of the event by the client for any reason shall forfeit the deposit. Cancellation of the event by the client WITHIN 7 DAYS of the date of event shall also require payment of the balance to Theil Fogerty, unless the event is rebooked by the client for an open date within 30 days of the cancelled date. Payment of the balance will **not** be required if the act obtains a suitable substitute booking elsewhere, or if cancellation is due to a verifiable death in the immediate family of the client. Cancellation by the client due to a major rain storm that is in progress on the date of event must be received no later than 8:00am on the date of the event. A client cancelling their event by telephone must also verify that cancellation in writing (via dated mail or FAX).

9. Travel Fees: If your event is 25 or more miles from us there will be a gas surcharge added for the artist to compensate for the extra time and gas that will be invested in getting to and from your event. Gas Surcharges are as Follows: 25 to 35 miles - \$20.00, 35 to 49 miles - \$35.00, 50 to 70 miles – \$50.00
